GENERAL TERMS AND CONDITIONS

These Terms and Conditions govern the relationship between you, the trip purchaser and us, Live It, LLC. By booking a trip you agree to be bound by these Terms and Conditions. They outline, among other things, limitations of liability and our cancellation policy. Please review these terms carefully since they affect your rights to sue, governing law, forum and jurisdiction; and make sure you understand your rights and obligations and our rights and obligations. In addition, we strongly recommend you purchase travel protection.

Passports and Visas

Valid passports are required for all United States citizens traveling outside of the continental United States. Your passport number, name and expiration date are required when you send in your deposit. Go to www.travel.state.gov for information pertaining to passport requirements and deadlines. Live It, LLC is not responsible for your failure to obtain the necessary passport prior to your trip and should you fail to do so, Live It, LLC will provide only that refund due pursuant to your cancellation policy.

Cancellation

If for any reason you cancel your trip, you must do so in writing. Cancellation refunds will be calculated as of the date we receive your written cancellation. All payments for travel services not provided to the passenger shall be refunded in accordance with these Terms and Conditions and in accordance with Live It, LLC's cancellation policy.

Processing Fee: In addition to any cancellation penalties, there is a standard non-refundable fee of \$150 per person for each trip you cancel (the fee for customized trips is \$300 per person). This fee reflects only our costs of administering a reservation. We realize the majority of those cancel their reservations do so out of necessity. Please note that if you cancel on or after the scheduled date of departure, you will not receive any refund.

Cancellation Charges: Unless otherwise stated, for all cancellations we will refund the cost of your trip less the following per-person charges.

Up to 90 Days Prior to Trip Departure	Full refund minus \$150 Admin Fee
Up to 60 Days Prior to Trip Departure	Refund of 50% of Trip Price
Up to 30 Days Prior to Trip Departure	Refund of 25% of Trip Price
Cancellation of Trip with less than 30 days to Trip Departure	No Refund

Medical Issues

If you have a medical issue that will require professional care while on the trip, you must bring and be responsible for all necessary items and treatment related to your condition.

Live It, LLC reserves the right to decline any trip participant whose condition, in our opinion, may affect the health, safety or enjoyment of other participants. Live It, LLC is not responsible for the costs of any medical treatment you may require during the trip. Under no circumstances is Live

It, LLC responsible for the quality of medical care, or lack thereof, you may receive while on the trip. We strongly recommend that you obtain medical and dental insurance that will cover the cost of any medical and dental assistance you may require during your trip.

Responsibility

The responsibility of Live It, LLC and its affiliated companies is strictly limited. As a tour operator, Live It, LLC organizes, promotes and sells trips consisting of certain travel services, including surface, air and water transportation, sightseeing excursions, and cruise/barge/hotel accommodations that Live It, LLC purchases or reserves from various suppliers (collectively 'Suppliers'). Live It, LLC does not own or operate any of these Suppliers. The Suppliers providing travel services for Live It, LLC's trips are independent contractors, and are not agents or employees of Live It, LLC. As such, Live It, LLC is not responsible for any negligent or willful act or failure to act of any supplier or of any third party. Some trips include visits to shops and merchants. Live It, LLC is not responsible for any purchases you make during your trip, whether that merchant is a part of the scheduled itinerary or not. By utilizing the travel services of the Suppliers, you agree that you will look to such Suppliers for any accident, injury, property damage or personal loss to you or to those traveling with you, and that neither Live It, LLC or any representative of Live It, LLC shall be liable.

Without limitation, Live It, LLC is not responsible for any injury, loss or damage to person or property, death, delay or inconvenience in

connection with the provision of or failure to provide, any goods or services occasioned by or resulting from (but not limited to) acts of God or force

major, acts of war or civil unrest, insurrection or revolt, strikes or other labor activities, criminal or terrorist activities of any kind, overbooking or

downgrading of accommodations, mechanical or other failure of airplanes or other means of transportation or the failure of any transportation mechanism to arrive or depart on time, sanitation problems, lack of medical care, or for any other cause beyond the direct control of Live It, LLC. Live It, LLC does not act as an agent for any party whatsoever.

Live It, LLC reserves the right to decline to accept or retain any person as a member of a trip or to cancel or alter the trip without notice, in which event your sole remedy shall be a prorated refund for any unused portion of the trip. Hotels and other accommodations are subject to change.

Governing Law

This relationship shall be governed by the laws of the State of Connecticut. Any claims against Live It, LLC must be brought in the Federal or State Courts located in the State of Connecticut, to the exclusion of any other state and country.
